# **EXECUTIVE SUMMARY**

- Premium Facilities manage Netstrata Jubilee Stadium, Penshurst Park, Hurstville Oval along with the maintenance of Tier 1 fields being Olds Park and Harold Fraser Oval. In addition, Premium Facilities manages the leases and management agreements at Council's other high profile sporting facilities.
- 2. The purpose of this report is to update the committee on the status of the grounds and sites in the Premium Facilities portfolio.

# **BACKGROUND**

- 3. The St George Illawarra Dragons commenced their home season at Netstrata Jubilee Stadium on 23 March 2024 against the North Queensland Cowboys. A family fun day for St George Illawarra Dragons members followed on the Sunday, 24 March.
- 4. The Junior Representative fixtures for St George District Junior Rugby League have also been played at the stadium on 10 February, 16 March and 30 March.
- 5. In preparation for the winter season, the Netstrata Jubilee Stadium pitch renovation, that includes an oversew with rye grass, will commence on 2 April and completed by 30 April, during which the pitch is unavailable. This non-availability has been conveyed to stakeholders.
- 6. Football St George have access to Hurstville Oval on weekends from the end of April to the end of July and the Dragons Harvey Norman Women's Team will play fixtures at Hurstville Oval in August.
- 7. Hurstville Glory FC and St George City will utilise the Hurstville Oval for training once the sports lighting has been installed. The Hurstville Oval outfield will undergo renovation until the end of April to prepare the surface for the winter season.
- 8. Olds Park Oval is transitioning out of cricket season into AFL season with pre-season training commenced on the oval without boots.
- 9. The Penshurst Sporting Hub is consistently occupied for training through the week and matches on weekends for St George City FA and Hurstville Zagreb FC as well as Football St George for matches on available Sundays. St George City play their NPL1 home games at the venue. Regular school bookings occur during school hours.
- 10. Harold Fraser Oval is utilised year-round by St George District Rugby League for training in conjunction with their gymnasium located in the pavilion, and Carlton Rovers commenced pre-season training in February with matches expected to commence for Football St George on weekends in April.
- 11. Basketball equipment issues have been reported to Council at the indoor stadium at Hurstville Aquatic Leisure Centre. Council officers are currently obtaining quotations for

the replacement of the divider nets and planning for further equipment upgrading in the new financial year.

# Georges River Council Scheduled Turf Maintenance Update March 2024

- Council has undertaken its sports renovation program throughout the warmer months, ensuring
  optimal growing conditions. The weather has been in our favour this summer, and we have seen
  some great results within our sporting fields.
- We are currently in the changeover period from summer sports to winter sports. This consists of covering cricket wickets with natural turf or synthetic turf and over-seeding some of our cooch fields with Rye seed.
- Cooch fields go dormant in the winter months and applying rye seed can rejuvenate the grass, repair bare patches, reduce the risk of weeds, and strengthen and increase the health of the sporting fields.
- Council has applied a slow-release fertilizer to promote root growth and overall turf health and undertaken a weed control program to eliminate any weeds from germinating.
- Irrigation schedules are adjusted to accommodate cooler temperatures and reduced water requirements and monitoring soil moisture levels when needed.

# **Georges River Council Wet Weather Management Update March 2024**

Council monitors the weather predictions via the Bureau of Meterology and undertakes necessary inspections when required. When 10mm or more rainfall falls within 24 hours, a council officer will inspect:

- The fields for water present on the turf surface.
- The ground softness and saturation point. If the turf has reached saturation point, it will be damaged very quickly if played on.
- Council officers will also take into consideration multiple days of less than 10mm of rain and inspect accordingly.

# Two main issues need to be considered when deciding to close fields:

- 1. Player safety playing on wet and damaged fields may present safety issues.
- 2. Irreparable damage to fields Council needs to consider the decision to close the grounds for the benefit of the playing surface and also for the longevity of the season, including finals time.
