That a 20m 'Bus Zone, 8:00AM to 9:30AM and 2:30PM to 4:00PM, Monday to Friday, School Days Only' be installed on the northern side of Bellevue Parade, Allawah, adjacent to Church Lane, as per the plan in the report.

### **EXECUTIVE SUMMARY**

1. This report seeks the Committee's consideration of the installation of a 'Bus Zone' at Bellevue Parade, Allawah.


### BACKGROUND

- 2. Council has received multiple requests from residents, parents of children that attend St George Christian School, and local MPs to review the current traffic movements along Bellevue Parade, Allawah during school peak periods.
- 3. Bellevue Parade is an unclassified local road with unrestricted parking throughout the day. 'No Parking' restrictions are enacted during school peak periods only.
- 4. Council officers have investigated the concerns raised and undertaken consultation with St George Christian School to assess the existing traffic conditions and identify road safety issues, particularly during the afternoon pick up period.
- 5. St George Christian School advised they require a formalised 'Bus Zone' to assist with ensuring children can safely be dropped of, and picked up, by bus services.
- 6. Council officers have observed that during the school afternoon pick up period, long vehicle queues and delays are experienced by motorists along Bellevue Parade. Council officers observed that motorists would travel in the centre of the road and accelerate to bypass the queued vehicles.
- 7. Council officers have assessed that the implementation of double dividing line marking, extending the 'No Parking' restrictions and implementing a bus zone fronting school property adjacent to Church Lane will improve safety at this location.
- 8. Based on the number of objections received from the community regarding loss of on street parking, the proposal of double dividing line marking and extending the 'No Parking' restrictions has been withdrawn at this stage. Council will revisit the proposal in the future should the traffic safety issue not be resolved.

### PROPOSAL

9. That 20m of existing unrestricted parking on the northern side of Bellevue Parade adjacent to Church Lane be converted into a 'Bus Zone, 8:00AM to 9:30AM and 2:30PM to 4:00PM, Monday to Friday, School Days Only'.

- The responses 'Strongly Against' the proposal relate to the loss of unrestricted all day on-14. street parking for the proposed 'No Parking' extension and 'Bus Zone' installation.

# RECOMMENDATION

# **EXECUTIVE SUMMARY**

1. This report seeks the Committee's consideration to approve 'painted island' pavement line marking fronting 53 Moons Avenue, Lugarno.

# BACKGROUND

- 2. Council received requests from a local resident to investigate installing pavement line marking to prevent vehicles parking outside and blocking the front entrance of 53 Moons Avenue, Lugarno.
- 3. The resident at 53 Moons Avenue identified that they have health complications that requires an oxygen machine, which is difficult to manoeuvre in and out of their home with vehicles parked outside the front entrance.
- 4. The resident also identified that vehicles parked directly outside the front entrance prevent emergency vehicles and personnel from accessing their property.
- 5. Council officers investigated the concerns raised and observed that the property boundary, and associated front entrance to the home, is located directly adjacent to the kerb. As a result, parked vehicles in this location completely obstructs any ingress into, and egress from, the property.
- 6. 'Painted island' pavement line marking was subsequently installed in April 2024 outside the front entrance of 53 Moons Avenue, Lugarno to assist with this issue by giving a visual indicator to vehicles parking in the area.
- 7. Council has received further requests from the resident to undertake enforcement to prevent vehicles parking over the 'painted island', and provided several images of vehicles ignoring the line marking and parking over it.
- In order to undertake enforcement, as per Road Rule 2014 Reg 197 (a driver must not stop on a painted island), Council seeks the Committee's approval of the pavement line marking fronting to 53 Moons Avenue, Lugarno

# PROPOSAL

9. That 'painted island' pavement line marking be approved at the frontage of 53 Moons Avenue, Lugarno.



10. No financial implications associated with this report – the 'painted island' pavement line marking has been installed.

- 11. The proposed changes will impact the existing parking restrictions along Moons Avenue. This requires consultation letters to be distributed prior to any recommendations to Council.



7. No budget impact for this report, all associated costs to be borne by the developer.

### **RECOMMENDATION:**

That regulatory "No Stopping" signage be installed on Rossi Street, South Hurstville at the intersection with Connells Point Road, as per the plan in the report.

### **EXECUTIVE SUMMARY**

1. This report seeks the Committee's consideration to install regulatory "No Stopping" signage on Rossi Street, South Hurstville at the intersection with Connells Point Road.

### BACKGROUND

- 2. Rossi Street and Connells Point Road, South Hurstville are unclassified local roads. Their current road widths are 10m and 12m kerb to kerb, respectively, with unrestricted parking on both streets.
- 3. Council has received multiple requests from local residents to investigate this intersection to assess the existing traffic conditions and safety of vehicles.
- 4. Council officers have observed that vehicles currently park within 10m of the intersection on Rossi Street. This is a safety concern as it affects sight lines and vehicles' ability to manoeuvre the intersection.
- 5. As per NSW Road Rules Reg 170, vehicles are not permitted to park within 10m of an intersection.
- 6. There is existing regulatory "No Stopping" signage on the eastern side of Connells Point Road, at the intersection with Rossi Street.
- 7. Currently, there is no signage on Rossi Street, at the intersection, to advise motorists where to park.

### PROPOSAL

8. It is proposed to install regulatory "No Stopping" signage on Rossi Street, South Hurstville.



9. Within budget allocation – TfNSW Traffic Facility Grant – approximately \$400.

# **COMMUNITY ENGAGEMENT**

- 10. The proposed changes will comply with NSW Road Rules Reg 170.
- 11. Council officers have distributed notification letters to the affected residents on Rossi Street, South Hurstville.
