Item: ASS021-25 Utilisation of Second-Generation Anticoagulant Rodenticide

RECOMMENDATION:

- (a) That the report outlining Council's current and future utilisation of Second-Generation Anticoagulant Rodenticide within Council properties be received and noted.
- (b) That Council monitor the Australian Pesticides and Veterinary Medicines Authority's reconsideration of anticoagulant rodenticide approvals and registrations, and action management changes as required.

EXECUTIVE SUMMARY

- Council resolved in September 2023 (NM055-23 Cessation of the use of Second-Generation Anticoagulant Rodenticides) for the General Manager to prepare a report into the possible cessation of the use of Second-Generation Anticoagulant Rodenticides (SGARs) in or on any Council-owned and Council-managed properties and lands by Council staff and contractors.
- 2. Council officers have undertaken an investigation to determine the current extent of SGARs use by Council and the capacity and implications of stopping the use of these products as part of Council's rodent pest management processes.

BACKGROUND

- 3. Pest control solutions carried out by Council are vital for maintaining public health, safety, and community sentiment of Council owned/managed properties. The urbanisation of the Georges River Council Local Government Area makes it susceptible to pest infestations due to high population density, waste accumulation, and numerous food sources. Council implements a pest management strategy across 78 properties to control pests like rodents and cockroaches, which can spread diseases and cause property damage. These efforts include regular inspections and use of pest control methods, including Second-Generation Anticoagulant Rodenticides (SGARs) to effectively manage pest populations.
- 4. Second-Generation Anticoagulant Rodenticides (SGARs) are a class of rodenticide designed to control rodent populations by inhibiting their blood clotting mechanisms, leading to internal bleeding and death. SGARs are highly effective and require only a single feeding to be lethal, making them a popular choice for pest control in urban settings, including by Council contractors at 40 Council properties.
- 5. SGARs have been approved by the Australian Pesticides and Veterinary Medicines Authority (APVMA) for use in and around domestic, commercial, industrial and agricultural buildings. Council and its contractors adhere to legislative and implementation standards set out in the Pesticides Act 1999, Pesticides Regulation 2017, NSW Code of Practice and Standard Operating Procedures for the Effective and Humane Management of Rodents and the **Agricultural and Veterinary Chemicals (Agvet) Code**.
- 6. SGARs persist in the liver of rodent targets, posing a subsequent risk of bioaccumulation and secondary poisoning in predators, including species that do not generally consume rodents.

- 7. An investigation of effective alternatives to SGARs, including consultation with Pest Control contractors, identified few cost-effective management solutions at this stage based on the capacity to utilise SGARs. Alternatives included standard snap traps, repellents, and SMART rodent control boxes, which have cost or efficiency limitations.
- 8. The APVMA has commenced a reconsideration of anticoagulant rodenticide approvals and registrations in accordance with Part 2, Division 4 of the **Agvet Code**, to reassess the potential risks associated with the use of these products and consider whether labels carry adequate instructions to protect the health and safety of people, animals, and the environment.
- 9. The reconsideration process comprises "legislative, administrative and scientific elements, all of which play an essential role in the final regulatory decision of whether to support the ongoing registration of an agricultural and veterinary chemical product". Publication of the proposed regulatory decision is expected in July 2025.
- 10. Council officers will monitor the outcomes of this reconsideration, however, in the interim have identified a trial opportunity to cease the use of SGARs at three (3) Council properties within/adjacent to bushland in which possible predatory fauna inhabit. This trial at Oatley Park, H.V. Evatt Park, Hurstville Golf Course will involve the cessation of all rodent management activities.
- 11. Should rodent issues be identified at these sites, a recommencement of SGAR control methodologies, or commencement of currently unidentified control methodologies will be required.

FINANCIAL IMPLICATIONS

12. No budget impact for this report. Should alternative rodent management methodologies be required at the three cessation-trial sites or following a reconsideration by APVMA on the use of SGARs, a future report will identify financial implications.

RISK IMPLICATIONS

- 13. Strategic Risk 3: Assets and Infrastructure: The appropriate management of Council buildings includes, where required, the control of pest species through appropriate processes. The cessation to utilise SGARs as a pest control process may have an impact on the future integrity of buildings as a result of pest infestations.
- 14. Strategic Risk 5: Climate Change: The continued use of SGARs may have an ecological impact if native predatory fauna species are impacted by secondary poisoning.
- 15. Strategic Risk 6: Reputation: The continued use of SGARs may have a reputational impact if native predatory fauna are found impacted by secondary poisoning.
- 16. Strategic Risk 6: Reputation: An inability to appropriately manage pest issues, resulting in higher frequencies of pest infestations may have a reputational risk on Council's capacity to maintain public health, safety and community amenity.

COMMUNITY ENGAGEMENT

17. Council will commence an update to the Pesticide Use Notification Plan to inform the community about the use of pesticides in public places managed by Council. A public exhibition period of the updated Pesticide Use Notification Plan will provide community members and groups an opportunity to comment.
