

EXECUTIVE SUMMARY

1. This report seeks the Committee's consideration of the installation of 'No Stopping' restrictions signage at Stuart Street, Blakehurst.

BACKGROUND

- 2. In November 2024 TAC077-24 was resolved by Council:
 - a) That 'No Stopping' restrictions be extended surrounding the pedestrian crossing on Stuart Street, Blakehurst, as per the plan in the report.
 - b) That the 'Bus Zone' restriction be relocated further south on Stuart Street, Blakehurst, as per the plan in the report.
 - c) That 'No Stopping' restrictions be installed across the private lane access and driveway


Plan B shows this recommendation.

- 3. As per above resolution, signs were placed inconsistently outside 151 Stuart Street. This allowed for allowed one parking space for small vehicle or trailer which created a safety concern and inconsistency within the No Stopping area.
- 4. To remove the discrepancy of the Council resolution, Council proposes to implement 36m of continuous 'No Stopping' restrictions frontage to 145-153 Stuart Street as per Plan A in the report.


PROPOSAL


1. This report seeks the Committee's consideration of the installation of '1P Parking' restrictions signage at Pearl Street, Hurstville.

BACKGROUND

- 2. Council has received multiple requests from business along Forest Road corner of Pearl Street to investigate and implement time restricted parking along Pearl Street and Bassett Street to assist customers finding parking close to the business along Forest Road.
- 3. Following investigation by Council officers, it was observed that currently parking is not permitted along northern side of Forest Road adjacent to Pearl Street frontage to 456-460 Forest Road due no stopping restrictions and bus zone restrictions.
- 4. The proposed '1P Parking' restrictions can accommodate four standard size vehicles, therefore will increase parking turn over to assist business and customers.
- 5. Current no parking restriction in Pearl Street during waste collection days will be maintained 'No Parking, 2pm Mon 7am Tue, 2pm Thu 7am Fri', adjacent to the bin rooms at 458 Forest Road.

PROPOSAL

- 6. That a 13m '1P Parking' restrictions be installed in Pearl Street during Mon-Fri 8:30am 2pm and Sat 8:30am 12:30pm, adjacent to the bin rooms at 458 Forest Road, Hurstville, as per the plan in the report.
- 7. That a 12m '1P Parking' restrictions be installed in Pearl Street during Mon-Fri 8:30am 6pm and Sat 8:30am 12:30pm, adjacent to 458 Forest Road, Hurstville, as per the plan in the report.

EXECUTIVE SUMMARY


1. To improve safety through improved sight lines, this report seeks the Committee's consideration of the installation of 'No Stopping' restrictions signage at Connells Point Road, South Hurstville.

BACKGROUND

- 2. Council has received multiple requests from residents to investigate and implement regulatory 10m 'No Stopping' restrictions at the intersection of Connells Point Road and Mimosa Street, South Hurstville, to provide sufficient sight lines for motorists travelling through the intersection safely.
- 3. Following an investigation by Council officers, it was observed that currently there are 'No Stopping' restrictions provided all approaches except eastern side of Connells Point Road north of Mimosa Street. Due to lack of signage motorists were parking within 10 metres of the intersection creating difficulties to observe oncoming traffic when egressing the street particularly for vehicle exiting Mimosa Street into Connells Point Road.
- 4. As per the Australian Road Rules, motorists are not permitted to stop within 10m of an intersection.
- 5. The proposed signage will ensure that there are sufficient space and sight lines for motorists travelling through the intersection safely.

PROPOSAL

6. That a 10m 'No Stopping' restrictions be installed on the eastern side of Connells Point Road north of Mimosa Street, South Hurstville as per the plan in the report.



7. Within budget allocation – TfNSW Traffic Facility Grant – approximately \$300 for signage.

EXECUTIVE SUMMARY

1. This report seeks the Committee's consideration of the proposed temporary 'Works Zone' extension fronting 16 Kensington Street, Kogarah, and temporary relocation of a 'Taxi Zone', to be located at 26-28 Kensington Street, Kogarah.

BACKGROUND

- 2. The builder of a Council approved development at 16 Kensington Street, Kogarah has requested to extend a current Works Zone, to be placed on the frontage of their development. The development involves the construction of a multi-level facility including a 3-level underground car park for St George Hospital 'Stage 3' (SSD-39170713).
- 3. The requested period of the 'Works Zone' extension is 12 weeks commencing mid-June 2025.
- 4. The 'Works Zone' will provide an area where vehicles associated with the works can park and receive deliveries closer to their site.
- 5. The current parking restrictions is a 'Taxi Zone', which will be temporarily relocated, fronting 26-28 Kensington Street, Kogarah.
- 6. The requested period for the relocation of the 'Taxi Zone' is 8-12 weeks commencing mid-June 2025.
- 7. Council consulted with St George Cabs and are in agreeance with the temporary 'Taxi Zone' arrangement request.
- 8. Current parking restrictions fronting 26-28 Kensington Street, Kogarah is '1P parking zone' 8:30am to 6pm Mon- Fri, 8:30am to 12:30pm Sat.

1. This report seeks the Committee's consideration of the proposed 'No Stopping' extension fronting 58 Bonds Road, Peakhurst.

BACKGROUND

- 2. Council has received a request from a local resident to extend the current 'No Stopping' restrictions to improve sight lines for vehicles accessing and egressing the property.
- 3. Following further investigation by Council Officers, it has been observed that vehicles are blocking portion of the driveway. Parked vehicles are also creating an unsafe ingress and egress to all motorists within the location.
- 4. There is a telegraph pole which is located near the lip of the driveway, causing further confusion to motorist looking for a parking space.
- 5. The location has unrestricted parking.

PROPOSAL

6. It is proposed to extend a current 'No Stopping' zone by 9.5m to the southern side of a driveway fronting 60 Bonds Road, Peakhurst to provide sufficient space for vehicles accessing and egressing the property.



7. Within budget allocation – TfNSW Traffic Facility Grant – approximately \$200.

COMMUNITY ENGAGEMENT

- 8. Residents have been notified by letter of the proposed parking changes. The closing date for submissions was Monday 2 June 2025.
- 9. Council has received one response strongly in favour for the proposal, the committee will be updated if additional responses are received.

EXECUTIVE SUMMARY

1. This report seeks the Committee's consideration of the proposed signage in Penshurst Street, Penshurst. To allow improved access to the Australia Post Office.

BACKGROUND

- 2. Council has received requests from Australia Post and Council Rangers to further formalise the Bus Zone along Penshurst Street, Penshurst.
- 3. Council officers have reviewed the request and to avoid further infringements to Australia Post vehicles, found the current Australia Post Office is located within a 'Bus Zone', therefore, additional conditions are needed.
- 4. The additional conditions will allow Australia Post vehicles to stop and unload safely without attracting any further infringements.
- 5. The proposal will have no impact to on street parking.
- 6. U-go Mobility have raised objection to the proposed signs due to the existing 7 days services (941, 943 and 945) to 10.45pm Mon to Sat and to 9.25pm on Sundays.

PROPOSAL

7. It is proposed to install '6am-7pm – Mon-Sat - Authorised Australia Post Vehicles Excepted' on existing 'Bus Zone' signs in Penshurst Street, Penshurst.



8. Within budget allocation – TfNSW Traffic Facility Grant – approximately \$350.

COMMUNITY ENGAGEMENT

- The proposed changes are within a 'Bus Zone' and will not directly impact any residential parking.
- 10. U-go Mobility have raised objection to the proposed signs due to the existing 7 days services (941, 943 and 945) to 10.45pm Mon to Sat and to 9.25pm on Sundays.
