



EXECUTIVE SUMMARY

1. That the Georges River Council Sports Advisory Committee receive and note the update within this report from Executive Manager City Futures on the Carss Park Aquatic Facility.

BACKGROUND

- 2. Georges River Council and the Office of Sport signed a Project Agreement in April 2025.
- 3. Since the previous update in May 2025, the following actions have occurred.
- 4. The Project Control Group (PCG) meets fortnightly and has 4 voting members, two from Council and two from Office of Sport. Council's voting members are Andrew Latta, Director Assets and Infrastructure and Kent Stroud, Executive Manager City Futures.
- 5. The PCG oversees the delivery of the scope, time and cost of the project. The PCG is working to complete the project due diligence by mid-August.
- 6. The milestones due to be completed by the PCG for mid-August are:
 - (a) Confirm project scope and budget;
 - (b) Complete due diligence of the site; and
 - (c) Complete the Project Management Plan including Communications Plan.
- 7. The PCG reports to the Steering Committee (SteerCo). The SteerCo has two voting members, one from Council and one from the Office of Sport. Council's voting member is David Tuxford, General Manager. The SteerCo meets approximately every month and approves the recommendations from the PCG.
- 8. The SteerCo have met twice since the last update. The SteerCo met in July to discuss the finalisation of the project scope and costings. A Quantity Surveyor has been engaged to provide costings once the scope is finalised. The specifications of pool are still to be determined.
- 9. Council officers have requested that the Office of Sport provide a briefing to Councillors when the project scope and costings are finalised.
- 10. The Office of Public Works will deliver the construction of the pool on behalf of the Office of Sport. Indicative dates for Project Completion (PC) are late 2027. The PC will be dependent on the scope, planning pathway and includes time contingency for weather. The intention is to have the pool open for the 2027 summer season.
- 11. The next PCG is scheduled for 12 August 2025.

FINANCIAL IMPLICATIONS

12. No budget impact for this report.

RISK IMPLICATIONS

13. Strategic Risk 3: Assets and Infrastructure: Work on a future Carss Park Aquatic Facility meets the evolving needs and expectations of the community, particularly in terms of quality, capacity, and resilience.

That the Georges River Council Sports Advisory Committee receive and note the presentation provided by the Senior Community Development Officer – Good Sports Program, from the Alcohol and Drug Foundation and Project Officer – Policy and Planning from the NSW Office of Sport, outlining the strategic framework of the Good Sports Program and Office of Sport resources.

EXECUTIVE SUMMARY

- 1. The Alcohol and Drug Foundation's Good Sports Program aims to support community sporting clubs to create safer, respectful and more inclusive environments.
- 2. The program works with clubs to develop strong governance frameworks by enhancing policies and practices relating to alcohol consumption, sales and management, illegal drug use, safe transport, responsible celebrations, and mental health support. These focus areas are essential for preventing behaviours that contribute to antisocial incidents at sporting events.
- 3. This support also helps clubs better understand and comply with legal requirements. As a result, clubs are empowered to operate confidently, responsibly, and in line with community expectations.
- 4. Prior to the Sports Advisory Committee (SAC) meeting on 14 August 2025, SAC community members attended a workshop facilitated by the Senior Community Development Officer Good Sports Program, Alcohol and Drug Foundation and the Project Officer Policy and Planning from the NSW Office of Sport regarding the Alcohol and Drug Foundation Good Sports Program strategy and Office of Sport resources.
- 5. On 23 June 2025 Council resolved (NM046-25):

That Council:

- (i) Acknowledges the recent violent incident that occurred on Saturday, 18 May 2025, at a grassroots soccer match at Gannon's Park, Peakhurst involving a brawl between spectators and players. This incident received widespread media attention and raised significant concerns about the safety and wellbeing of players, referees, volunteers, and spectators within the Georges River local government area.
- (ii) Recognises the important role that local government plays in promoting safe, inclusive, and respectful environments in community sport, particularly when matches are held on Council-managed facilities.
- (iii) Continue working proactively via the Sports Advisory Committee to:
 - Promoting respectful conduct on and off the field;
 - Prevent violence, abuse, and antisocial behaviour during matches;

- Support referees, coaches, and volunteers with conflict resolution tools and mental health support; and
- Promote fostering sportsmanship, community values, and respectful conduct at all matches.
- (iv) Writes to Football St George requesting that they:
 - Identify any additional support required from Council or State Government to enhance safety and referee protection at grassroots sporting events; and
 - Consider introducing a zero-tolerance policy to deter poor behaviour by players and spectators.
- (v) Further, following the adoption of the Sports Ground Access Policy at the June 2025 Council meeting, Council notify in writing all hirers of Council's sportsgrounds to reinforce their shared responsibility to uphold the policy's principles, including the standards of conduct and behavioural expectations required when using these facilities, and the commitment to providing safe and inclusive environments.
- 6. The presentation attached aligns with parts (a)(ii) and (a)(iii) of this Council resolution, reconfirming Council's commitment to enhancing the safety and wellbeing of all participants, officials, volunteers and spectators involved in community sport.
- 7. Additionally, in alignment with part (a)(iv), the NSW Office of Sport provided input to enhance safety and referee protection at grassroots sporting events.

FINANCIAL IMPLICATIONS

8. No budget impact for this report.

RISK IMPLICATIONS

- 9. Strategic Risk 6: Reputation There is a risk to Council's reputation if antisocial behaviour continues at Council-owned sports grounds, which may undermine community trust in Council's ability to provide safe facilities and ensure community wellbeing. By supporting initiatives like the Good Sports Program, Council mitigates reputational risk by promoting a culture of respect and responsibility across local sporting communities.
- 10. Strategic Risk 8: Social Cohesion There is a risk that continued antisocial behaviour could contribute to the erosion of social cohesion, particularly in a diverse and growing community where sport plays a vital role in bringing people together. By supporting education and behavioural change through the Good Sports Program, Council is actively working to strengthen sportsmanship behaviour and prevent future antisocial behaviour in grassroots sport.







Sports Field Maintenance Updates

Sports Ground Maintenance

Maintenance activities across approximately 387,000m² of managed sports turf, aimed at improving surface quality, playability, drainage and resilience to seasonal and usage-related stress.

Weed control

Spring application of herbicides targeting bindii, clover and invasive species to suppress growth before summer.

Pest management

Targeted pesticide treatments for couch mite, curl grub and armyworm using turf-safe insecticides.

Fertilisation

High-nitrogen, potassium and trace element blend applied to boost turf recovery, density and root strength.

Irrigation

Seasonally adjusted and weather-responsive irrigation to optimise turf health and prevent overwatering.

Topdressing and drainage

700 tonnes of sand-soil blend used to level surfaces and improve drainage in low-lying areas.

Turf repairs

Patching in high-wear zones to maintain a consistent playing surface.

Wet Weather Policy and Field Closures

Utilisation of Wet Weather Procedure and Ground Assessment

Over-Sowing for Winter Coverage

To maintain turf coverage during couch dormancy, high-use fields were over-sown with a perennial rye grass blend to ensure safe and playable surfaces throughout the winter sports season. Fields over-sown include:

- Claydon Reserve
- Charles Pirie Field
