

Mortdale 'B' Streets

W Delezio: Can Council provide any update in regard to the roundabout?

A Latta: No update at this stage. We are progressing with some recommendations at the moment, Council is hoping to have those recommendations in the next few months.

Traffic Study on Forest Rd, Lugarno

W Delezio: Does Council have any update on the installation of speed calming devices on Forest Road?

M Mahmud: Council is planning to do additional speed and traffic volume counts in August this year on a different location that is not currently included in the traffic study. Once this has been

completed, Council will proceed with consultation for the four existing locations. If the additional location meets the warrant, then it will be added to the study as well and proceed from there.

Oatley Traffic Study

W Delezio: I know there were some recommendations for this traffic study, does Council have an update?

M Mahmud: Council are planning to complete traffic counts in August and then will proceed with traffic modelling to assess whether a roundabout is feasible first. If it is found to be feasible, then Council will proceed from there.

Hurstville Rd and East Crescent, Hurstville Grove

W Delezio: There are a number of residents complaining about speeding on this street. Can St George Police include patrol in this location?

F Xu: Yes, we will include this location in our monthly meeting with St George Highway Patrol.

Waitara Parade, Hurstville Road

W Delezio: Same issue at this location. One resident has complained about speeding along this road a few times, would appreciate if St George Police could patrol this location.

F Xu: No problem, please send through your enquiry via email with the required locations, time and date.

Lugarno Chivers Hill Carpark

W Delezio: Resident mentioned that there has been speeding in this location and that there has been one injury over there. Can Council investigate speed humps in this car park?

M Mahmud: Yes, Council will investigate.

Proposal for Carrington and Warwick Street, Hurstville

L Crompton: Has there been any update or any progress thus far on this matter? What is going to be done? Is there some other design of the roundabout?

A Latta: This particular intersection has been included in this year's Capital Works budget, there is money allocated there. Assessment of the feasibility of the roundabout is still ongoing. However, it is not likely that a roundabout will be feasible due to the proximity of other services, particularly the electricity assets/utilities. Currently, Council is assessing other alternatives.

L Crompton: Is it possible to put in a barrier or some sort of speed calming device so that drivers will slow down as they come from Hurstville down towards Stoney Creek Road? This might resolve the problem and pacify residents. Please keep up with this.

A Latta: Yes, Council will look into it.

Hurstville School Precinct Study

L Crompton: Outside Sydney Technical High School and Bethany College, I believe progress has been made thus far. Can Council provide an update?

A Latta: That study has been completed and a number of recommendations came out of that study. Council is currently working through our part of those recommendations. There are also some recommendations that sit with Transport for NSW (TfNSW), who are progressing with items like the pedestrian footbridge overpass. There are a number of things that are being worked through at the moment. There is money allocated in Council's budget this year to affect improvements. TfNSW will also work through their parts.

L Crompton: Is Bayside Council also involved?

A Latta: Yes, Bayside Council is also involved. There is a working group that has been established and they meet bimonthly. That working group involves all the schools within that precinct, Georges River Council, Bayside Council and TfNSW.

L Crompton: Has there been some results that have come out of that working group that has been made public?

A Latta: That study has been made public, either at the last Council Meeting or the one before. Currently, it is a work in progress.

Beverly Hills Commuter Car Park

Deputy Mayor N Liu: A few months ago, I put in a motion for Council to write to TfNSW, Mark Coure MP, and The Hon. Chris Minns. Did we hear anything back from those parties?

A Latta: Council is still awaiting response, we have written to them previously on a number of occasions, requesting the same information. We are still waiting.

Deputy Mayor N Liu: From my memory, the businesses and Mark Coure MP also provided a petition, therefore it was a combined motion to Council. If Council has not heard from the other parties, can Council please chase up for feedback?

W Delezio: Mark Coure's office have heard back from TfNSW, they have stated that this is not feasible, whether that is a policy choice or whether it is not physically feasible, we are unsure. Our office has already written back again, we will provide you with an update of what we hear.

A Latta: The information that we have received from TfNSW previously was that there are some issues with the interaction between Opal and making the commuter car park free for parking. There were some technical issues that they had to work through if it was going to be feasible. Council has heard a similar response in the past but we just have not received a response as of yet.

Deputy Mayor N Liu: If that is the response received, is there anything that we can do further? Feedback from the community is that this matter is severely affecting businesses due to parking problems in Beverly Hills. I provided data at a previous Council Meeting which demonstrates that the car park is being underutilised, particularly during the day time. I hope that Council can represent and advocate for the community, so that we can all work together to find a solution.

A Latta: The site is now state government owned, there was a compulsory acquisition for that site prior to the construction of the commuter car park. This is now all in the hands of TfNSW, Council can only advocate for more parking, however, it comes down to the willingness of TfNSW.

Deputy Mayor N Liu: I remember at that time, The Hon. Chris Minns also advocated that this car park was to be open to the public and not only to commuters. Hopefully, Council can continue to advocate for this. If we hear back from TfNSW, can we please revisit at a future Council Meeting?

A Latta: Yes, Council will continue to assist on this matter.


1. This report seeks the Transport Forum's consideration of the installation of 'No Parking' restrictions signage on the western side of Wright Street, Hurstville.

BACKGROUND

- 2. In 2024, Council engaged WSP traffic consultant to conduct a traffic study at Hurstville School Precinct, which comprises six schools including Hurstville Public School, Hurstville Adventist School, Georges River College, St Marys Catholic Primary School, Bethany College, and Sydney Technical High School.
- 3. One of the recommendations from the traffic report was to provide the pick-up/drop-off (PUDO) zone on the western side of Wright Street, Hurstville to meet high PUDO demand.
- 4. Currently there are PUDO area provided on the eastern side of Wright Street frontage to the school.
- 5. Following investigation by Council officers, Council proposes to convert 26m of unrestricted parking area into a 'No Parking' area during school PUDO time.
- 6. In addition, Council also recommends to relocate the 'Bus Zone' and 'No Parking, School Days' signage on the eastern side of Wright Street slightly to the north.
- 7. The proposed changes to the parking restrictions would result in a loss of some 26m of unrestricted parking (four spaces) on the western side of Wright Street during the school AM and PM peak periods.

PROPOSAL

- 8. That a 26m of unrestricted parking area be converted into a 'No Parking, 8am 9:30am and 2:30pm 4pm, School Days' restriction on the western side of Wright Street, Hurstville opposite Adventist School frontage, as per the plan shown in the report.
- 9. That the existing 'Bus Zone' and 'No Parking, 8am 9:30am and 2:30pm 4pm, School Days' signage on the eastern side of Wright Street, Hurstville be relocated slightly to the north, as per the plan shown in the report.



10. Within budget allocation – TfNSW Traffic Facility Grant – approximately \$400 for signage.

COMMUNITY ENGAGEMENT

- 11. Council has undertaken community consultation with the residents and school of the proposed changes to the parking restrictions on the western side of Wright Street, Hurstville.
- 12. School has raised the concerns that proposal may encourage parents to crossing the midblock section of Wright Street instead of pedestrian crossing during PUDO activities.
- 13. Council has recommended proper education and communication from the school to encourage parents to use the pedestrian crossing in Wright Street. Council will monitor the safety issues post implementation of the restrictions and take appropriate traffic management measures in the future.





- 2. Council has received requests from Hurstville Public School to investigate and implement yellow line marking along the existing No Stopping restrictions on the western side of Forest Road adjacent to Lily Street to stop parents utilising this area for illegal pick-up/drop-off (PUDO) activities
- 3. Following investigation by Council officers, it is observed that due to pedestrian fencing along Forest Road, illegal PUDO activities on the existing no stopping area creates potential safety hazards for both parents and students.
- 4. The proposed yellow line marking would reinforce the 'No Stopping' restrictions in this section of Forest Road and improve safety.
- 5. It was also observed that there is a conflicting existing signage on the northern end of the 'No Stopping' sign pointing south, where a 'No Parking, 6:30am 9:30am, Mon-Fri' restrictions signage pointing both directions.
- 6. To prevent discrepancy, it is recommended to convert 'No Parking' signage pointing both directions into north on the western side of Forest Road adjacent to Lily Street, Hurstville.

This report seeks the Transport Forum's consideration to install regulatory 10m 'No Stopping' restrictions on all approach and departure lanes at the Newman Street and Villiers Avenue intersection to improve sight line and provide safe manoeuvring space for motorists travelling through the intersection.

BACKGROUND

- 2. Council has received requests from residents along Villiers Avenue to investigate and implement regulatory 10m 'No Stopping' restrictions at the intersection of Newman Street and Villiers Avenue, Mortdale.
- 3. Concerns were raised about vehicles parking close to the intersection, which results in safety concerns and difficulties for motorists to manoeuvre the intersection.
- 4. Following an investigation by Council officers, it was observed that motorists were parking within 10m of the intersection, specifically along the western side of Villiers Avenue and the northern side of Newman Street.
- 5. Currently, there is no signage or line marking on the northern leg of Villiers Avenue and the northern side of Newman Street to advise motorists not to park too close to the intersection.
- 6. Council officers have also observed that existing 'No Stopping' restrictions are currently installed on both the approach and departure lanes of Cross Street and the southern side of Newman Street.
- 7. As per NSW Road Rules, vehicles are not permitted to stop within 10m of an intersection at any time.
- 8. There is a vehicular driveway for 2 Villiers Avenue, Mortdale located within 10m of the intersection. Therefore, it is proposed to extend the 'No Stopping' restriction to 13m on the eastern side of Villiers Avenue to avoid the driveway, as per the plan in the report.
- 9. The proposed 'No Stopping' restriction would improve the sight line and provide safe manoeuvring space for motorists travelling through the intersection.

PROPOSAL

10. It is proposed to install regulatory 10m 'No Stopping' restrictions on all approach and departure lanes at the intersection of Newman Street and Villiers Avenue, Mortdale as per the plan in the report.



11. Within budget allocation – TfNSW Traffic Facility Grant – approximately \$800.

- 3. As per the Australian Road Rules 2014 (Rule 211) which supports 'PARK IN BAYS ONLY' signage, introduction of signage along the street will assist with safe vehicle thoroughfare.
- 4. There will be no changes to the on-street parking availability due to the proposal.
- 5. The proposed 'PARK IN BAYS ONLY' restrictions will improve traffic flow and safety along Bembridge Street, Carlton.

PROPOSAL

6. That regulatory signage 'PARKS IN BAYS ONLY' at the East and West ends of Bembridge Street, Carlton be installed.



7. Within budget allocation – TfNSW Traffic Facility Grant – approximately \$500 for signage


1. This report seeks the Transport Forum's consideration to install 'No Stopping' and 'No Parking' restrictions on the northern side of Woniora Road to improve sightline for motorists exiting the driveway and reduce southbound delay at the Woniora Road and Greenbank Street intersection.

BACKGROUND

- 2. Council has received requests from the residents of Woniora Road, Hurstville to investigate and implement parking restrictions along Woniora Road, specifically on the northern approach to the Woniora Road and Greenbank Street intersection to stop vehicle parking close to the driveway and blocking southbound kerbside lane.
- 3. Following an investigation by Council officers, it was observed that parked vehicles within this section of the road obstructing the sight line for motorists exiting the adjacent driveway. In addition, parked vehicles could create significant southbound queuing and delay for motorists at the Woniora Road and Greenbank Street intersection especially during AM and PM peak periods.
- 4. The proposed no stopping and no parking restrictions would prevent motorists from parking along the northern kerbside of Woniora Road, hence improve road safety concerns for motorists exiting the driveway and improve delay and queuing at the intersection.
- 5. The proposed changes to the parking restrictions will have minor impact to the current onstreet parking demand, as motorists generally are not parking their vehicle in this section of road due to high volume of traffic on Woniora Road.

PROPOSAL

- 6. It is proposed to install a 55m 'No Stopping' restriction on the northern side of Woniora Road, Hurstville as per the plan in the report.
- 7. It is proposed to install a 62m 'No Parking' restriction on the northern side of Woniora Road, Hurstville as per the plan in the report.



8. Within budget allocation – TfNSW Traffic Facility Grant – approximately \$1,000.

COMMUNITY ENGAGEMENT

- 9. Council has conducted a community consultation with residents within the vicinity of the proposal.
- 10. Council has received two responses regarding the proposal. One response is 'In Favour' of the proposal and another response is 'Strongly Against' the proposal.
- 11. The residents against the proposal concerns about the inconvenience due to lack of pick-up/drop-off locations along the site frontage.
- 12. The proposed change would provide some 62m of 'No Parking' restriction along the Woniora Road site frontage, which permit motorists to stop for a period up to 2 minutes to drop-off and pick-up passengers while staying within 3m of their vehicles.
